2. The judgments' and Awards will be made by an independent panel of judges, and its decision will be final.
3. Individuals or Companies can submit one or more items for the Competition. The maximum number of articles permitted on each application form is Five, and cannot exceed this number. Any number of Applications can be submitted under similar names. An Entry Fee of Rs.250/- will be charged for each application. Cheques should be drawn in favor of 'Gemmologists Association of Sri Lanka', crossed 'A/c Payee Only', and or deposited at the Commercial Bank, Colombo 3 (swift code CCEYLKX) to the credit of A/c. No.1110034276. Payments could also be made by cash, to the Treasurer, GASL, on the preliminary judgment date.
4. Full description of exhibits should be attached to the Application Form, such like, the Article No., Title, Name, Weight, Colour, and the Species Name. These details should be clearly displayed at the Competition Booth.
5. The Competition is open to Sri Lankans only. Borrowed or third party articles are not accepted for the competition. The organizers are not responsible for the ownership of the articles sent for the competition.
6. Reproductions of articles or photographs are not accepted for the competition. A written testimonial will be required regarding the authenticity of the article.
7. Applications and articles must be submitted to the GASL, for the preliminary selection. Preliminary selection of articles is scheduled on the 9<sup>th</sup> of December 2017, at the OPA Auditorium, from 9.00 a.m. onwards.
8. Applications should reach the Chairman, Jewels Competition, Gemmologists Association of Sri Lanka, Professional Centre, 275/75, Prof. Stanley Wijesundera Mawatha, Colombo 7 or [jewels@gemmology.lk](mailto:jewels@gemmology.lk).
9. "Entries for Jewels Competition 2017" should be written on the top left hand corner of the envelope.
10. Immediately after the preliminary selection, photographs will be taken and articles will be released to the owners, and the selected items will be indicated.
11. The Final judgment will be made during the Jewels 2017 Exhibition & Competition by an independent panel of judges. Votes of Visitors to the exhibition will also be considered before the final decision.
