**RULES AND REGULATIONS OF THE JEWELS 2018 GEM & JEWELLERY TRADE EXHIBITION & COMPETITION**

- 1) BARE SPACE BOOTH HOLDERS can commence moving in their material and setting up their stalls by 03.00pm on the 16<sup>th</sup> November 2018. Construction /setting up of booths in the bare space must be finished by 6.00am on the 17<sup>th</sup> November 2018.
- 2) SHELL SCHEME BOOTH HOLDER Scan commence moving in their material and setting up their displays on 16<sup>th</sup>November 2018 from 06.00pm onwards. Setting up of booths & moving in their material /furniture must be fully completed by 06.00am on the 17<sup>th</sup>November 2018.
- 3) Exhibitor’s requirements of additional furniture / accessories should be informed and fully paid before 10<sup>th</sup>November 2018.
- 4) All the display materials, Constructions, furniture and any others materials used by the exhibitor should be removed only between 08.00pm on 18<sup>th</sup>November 2018 and 06.00am of 19<sup>th</sup>November 2018. No removal of such items will be allowed during the official exhibition hours.
- 5) Displaying exhibitor’s pass is a must for all exhibitors during the exhibition and only the pass holders should be engaged in any promotional work and transactions in the booth.
- 6) The Executive committee members of the Gemmologists Association of Sri Lanka bear the right in allowing the entry / removal of any person or material to/from the exhibition venue.
- 7) While the organizers take every possible step to ensure security, the organizers will not bear responsibility for the loss or damage of any items belong to anyone during the setting up/Exhibition hours/removal times.
- 8) No person under any circumstance shall cut, damage or alter any structure or damage any part of the exhibition hall. If any damage is caused, the exhibitor/person will have to pay for the damage.
- 9) Exhibitors shall not place any items/promotional materials anywhere in the hall other than within their own booth. Exhibitors or their representatives are not allowed to distribute brochures etc.near the entrance or anywhere in the hall other than within their own booth.
- 10)The exhibitor agrees to withdraw from display /sale any irrelevant merchandise when requested by the organizer.
- 11)The exhibitor must disclose any treatments / enhancements done to the gemstones for sale. The suitable action will be taken by the organizers if this is not done.
- 12)Exhibitor shall not transfer any rights to any other person/party without the consent of the organizers.

- 14)In the event of any occurrence not foreseen in these rules and regulations, the decision of the Executive committee of the Gemmologists’ Association of Sri Lanka shall be the final.
